#### **NJ Minimum Wage Increase**

New Jersey's Governor, Phil Murphy, recently announced that
New Jersey's statewide minimum wage will increase by \$1.00 to
\$15.13 per hour for most employees, effective January 1,
2024. This achieves and exceeds the goal set
by legislation signed by Governor Murphy in February 2019 to
raise the minimum wage to at least \$15 per hour by 2024 for most
employees.

### **How to Access Secure Encrypted Emails from Public Partnerships**

By clicking the title, this document will walk you through the process for accessing Office 365 (O365) encrypted email messages. Email encryption involves encrypting, or disguising, the content of email messages to protect potentially sensitive information from being read by anyone other than intended recipients.

#### Time4Care Offline 12/8 - 12/11

**Important Note:** PPL systems will be upgraded starting 8:00 pm ET on December 8, 2023, to 8:00 am ET December 11, 2023. During that time, the Time4Care application will be in off-line mode.

Please continue to submit your time in off-line mode and your timesheets will be uploaded after the system returns to online mode. Please **update** the app on Dec 9 or 10 to version 11.

All Time4Care users - **DO NOT UNINSTALL & REINSTALL** the app while the app is in offline mode from 8:00 pm ET Dec 8<sup>th</sup> through 8:00 am ET Dec 11<sup>th</sup>.
