### Pharmacy Benefit Program for Workers' Compensation

BAMS is pleased to introduce and roll out a Pharmacy Benefit Program as a solution for your Workers' Compensation costs.

*First Script* is affiliated with Coventry Integrated Services. The program is specifically designed for Workers Compensation claims ONLY. I've attached some valuable information that will explain in further detail HOW the program works and the benefit to be gained. Specifically:

- No out of pocket expense for your injured employees
- Formulary review
- Generic substitution
- Management of Dispensing
- Charges 8-12% on average below Fee Schedule
- Utilization and Savings Reports Quarterly
- No Fees

Also, attached is a letter that provides the Toll-Free # and instructions on how to utilize the program for your injured worker's pharmaceutical needs. It's actually quite simple:

- Give the injured worker the instruction sheet, which provides the location code that identifies you as a member of the *First Script* program.
- Instruct the employee to follow the directions as outlined. Simply, provide name, social security #, employer's name and location #. The pharmacist will phone the toll-free # and obtain membership confirmation to dispense the medication(s).

**Pharmacy Instructions**

Injured Worker's employer participates in First Script, a pharmacy benefit program administered by Medco. Call the First Script Help Desk, 24 hours a day, 7 days a week, at 1-800-791-2080 to verify employee eligibility, and receive Member ID #. First Script claims are submitted electronically and electronic approval of the claim will be returned.

*Pharmacy: You will not be required to submit any paperwork for this claim and payment is guaranteed for all electronically accepted claims.*
